SOLICITOR REMINDER:

Anyone soliciting in the Village of New Lebanon is required to obtain a permit and submit to a background check.

The permits are obtained in the village office for \$10.00.

Solicitors are required to carry said permit and present it upon request of any resident they contact in the village. They should also have an appropriate photo identification with them at all times.

Hours of solicitation are 8:00am to 9:00pm.

INCOME TAX



The Village of New Lebanon has a 1% income tax rate which applies to all who live, work, own property or operate a business in the Village of New Lebanon. This rate has remained unchanged for over 30 years. The earnings tax provides for many of the Village's services and major improvements. We do not give credit for tax paid to other municipalities.

WHO NEEDS TO FILE?

New Lebanon has a mandatory filing, everyone* 16 years or older must file whether you have any income or not. Every person* 16 years and older, who lives, works, or owns a business or rental property in the Village must file an income tax return whether taxes are due or not. Non-residents who received a salary, wages, commissions, and other earned income for work done or services performed or rendered within the Village and Non-residents who own rental property within the Village are required to file a return. Non residents who work in the Village and New Lebanon tax is withheld do not have to file. Non-resident taxes are computed on net income after allowable expenses. College students, even though they reside outside of New Lebanon for a portion of the year, are required to file if their permanent residence is New Lebanon.

*Military Active Duty Pay or Reserve Duty Pay is not taxable.

*If you are 72 years old and no longer have taxable income notify the office to change the status of your account and you will no longer need to file or you can check the box on the income tax form.

FILING:

Tax returns are due by April 15th for each year **QUESTIONS:** about New Lebanon Income Tax, contact Kelly Pinkerton at 937-687-1341 ext 101.

ZONING AND COMPLIANCE REMINDER

Properties are to be maintained up to codes and standards. It is the property owners responsibility to maintain their property, but for those who fail to upkeep their property, properly return their trash cans after pick up, park vehicles/RVs/trailers in places not intended for vehicles. and other non-compliance issues. The Village Zoning and Compliance Administrator, will be enforcing these codes. Overall, properties need to be maintained and kept in a condition as to not affect the value of any neighboring properties. Currently, letters are being sent to property owners warning them of violations but providing time for the owner to complete the needed maintenance before a citation is sent. If you are notified of a violation of zoning or compliance, do not ignore it. Reach out to Melody if you have any questions at 937-687-1341 ext 106. SERVICE DEPARTMENT UPDATE

In 2019, Phase I OPWC Church Street saw the completion of Church street from Perry St. to Main Street.

2020, will see Phase II OPWC Church Street, this project will mirror Phase I including underground utilities, curb, gutter, storm sewer, and two courses of asphalt. There will be one additional Phase to South Church Street in 2021. Each of the three Phases are approximately 1,000 feet in street length.

Local Street Levy, The streets throughout the Village need attention—all the streets, so all the streets are on the list for repair and resurfacing. We are in the process of assessing streets to determine need, and cost for repair/resurfacing, weather and wear enters as a factor of determination.

POLICE DEPARTMENT INFORMATION

Recap 2019 New Lebanon Police Department

Officers were dispatched to 2,840 calls for the year which resulted in 496 reports and 203 arrests. Officers preformed over 1,200 business checks over 1,500 security checks and hundreds of vacation house checks. Officer Oney completed Evidence Technician training, and Officer Wortman completed level 3 Traffic Crash training.

On 02-20-2020 at 11:28 pm, Office Jenkins was dispatched on a structure fire involving an oxygen tank on fire. Officer Jenkins was the first one on the scene, he found that there was one subject in the house who was not able to exit on their own. Officer Jenkins carried the person to safety as the house was on fire and filled with smoke. Before joining the New Lebanon Police Department, Officer Jenkins served 9 years in the United States Army completing two tours in Afghanistan and one in Iraq.





Resident Spotlight: Geraldine Louise (Creech) Caplinger



Gerry, has been a resident of New Lebanon since the seventh grade. She is currently 91 years young, so seventh grade wasn't really that long ago. When Gerry was sixteen, she worked at New Lebanon's Rouselius Restaurant, and in 1946, she graduated from Dixie High School. After graduation, Gerry began working at Egry Register in Dayton and then Delco Products in 1951, where she retired from in 1983.

Gerry attends Grace Methodist Church in Dayton, where she volunteers as head usher, member of the women's circle club, and lead cook/organizer of many church meals. She has been a member there since 1950 and is devoted to her faith and her family. Her family began in February 1951, when she married lifelong New Lebanon resident and 1941 Dixie graduate, and love of her life, John

Caplinger, who graduated from Dixie in 1963. Over the years, Gerry has helped raise her grandchildren and great grandchildren with love.

In the late 70's, Gerry became a member of The Preble County Historical Society staying an active member ever since. She received the Volunteer of the Year Award in 2003 in recognition of her outstanding service. Gerry was installed into The Farmersville Order of the Eastern Star in July of 1980. Gerry has held multiple offices there, including Worthy Matron 2004-2005. Even today, she continues to be one of the most active Eastern Star members. Over the past 30 years, Gerry has been an active member of The New Lebanon American Legion Post #762 Auxiliary, holding many Auxiliary of-

fices including President 1987-1989 and Auxiliary Treasurer, for the past 15 years.

If you can't find Gerry at the Legion, she can be found volunteering at The House of Bread in Dayton, providing to her neighbors in need with a ride, a meal, Bingo at the nursing home, a conversation to the lonely, or serving veterans with her time volunteering at the Dayton VA.

Geraldine, (Gerry), Caplinger is an amazing resident of New Lebanon, and representative of this Village, so the next time you see her take a second to say hello.
